Additional Regulations:

FEIF Worldranking Competition, all horses are mandatory to be registered on Worldfengur.

Equipment and shoeing checks following FEIF General Rules Sport. FEIF General Rules, ÖTO and ÖTO-I in its last version. All participating horses must carry sufficient liability and have to be vaccinated after FEI-Rules.

MEM titled Tests are: T1, T2, V1, F1, P1, P2, P3. PP1, Fourgate- and Fivegatecombination.

Test with MEM-Title: Preliminary Rounds handled all together. Finals separated in age classes.

Test without MEM-Title: Preliminaries and Finals will be ridden and ranked all together. (No separate ranking for young riders)

The **nation ranking** is determined based on the results of the team five-gate. For this test, each nation nominates 5 horse/rider combinations, each rider demonstrates one part of the five-gait-test. Riding in groups - based on the five-gate finale

The **qualification** for competing in MEM 2024 is subject to individual national regulations in the respective countries.

Helmet Duty for all tests. Starting Order will be drawn by lot. Starting boxes and electronic timekeeping for all pace races available.

Miscellaneous: Dogs have to be held on leash on all competition area! Horses must be sufficiently vaccinated against coughing/flu (following FEI General Rules - https://inside.fei.org/fei/your-role/veterinarians/biosecuritymovements/vaccinations) and they have to come from farms free of infectious diseases. The horses' passports have to be presented upon check-Vet Check at the Arrival: Horses Passports will be checked. On Wednesday August 14th there will be a mouth check for all horses taking part in the competition. For this purpose, time slots are allocated according to nations. Any re-checks and late arrivals will be checked on Thursday, August 15th. When reserving an "obtainable paddock" please note name and gender of the horse. Charged deposit (€ 40,- for boxes, paddocks.) will be repaied at departure only when the grounds are clean and mucked. For all participating horses it is mandatory to show an official veterinarian health certificate at the check-in (following guidelines 2009/156/EG. Anhang II). Otherwise participation on the competition is not possible. https://www.oeps.at/de/oeps-turnier-info-reiter (that means arrival with "Traces" complies to the law) **Doping control:** The provisions of the FEIF Rules and Regulations as well as the Austrian Tournament Regulations ÖTO § 56 ("..... The doping controls must be carried out in accordance with the provisions of the WADA Code and the Austrian Federal Anti-Doping Act in the currently valid version) apply to the event. The list of Prohibited substances are published by NADA Austria in the currently valid version (www.nada.at). Violations of the anti-doping regulations are punished in accordance with the provisions of the ADBG or § 2001.4.") Liability: Participation at own risk. Host and organizers will not carry any liability for accidents, illness or other damage cases of horse owners, riders, audience, grooms or horses. Horse owners and participants are personally liable for damage cases upon thirds, which they cause themselves, or their employees, their agents or their horses. All participating horses must carry sufficient liability. The competition itself is insured by OEPS. Data protection: Video images, photos and texts will be published from this event. In order to document the sporting event of MEM2024 and also for media support in order to increase the level of awareness of the Icelandic horse and its riders, photos and texts will be taken for the entire duration of the event, which will also
